ELCC Mandate:

The Métis Nation—Saskatchewan’s Early Learning and Childcare mandate is to develop culturally-distinct and safe, Métis focused programs and services for Métis children and families.

Funding Purpose:

In light of the COVID 19 crisis, Métis Nation-Saskatchewan will provide one-time payments to support Métis families with emergency childcare needs.

Application Criteria:

Métis families with Métis children registered as Métis citizens, through the Métis Nation – Saskatchewan Provincial Citizenship Registry, can apply for:

- One-time funding
- Métis children must be 10 years old or younger (born January 1, 2010 to August 15, 2020)
- Children must be registered Métis citizens with the Métis Nation—Saskatchewan Registry
- The Métis parent/guardian and children applying must be current residents of Saskatchewan for the past 6-consecutive months
- Only one custodial parent/guardian can apply
- Applications must include the Métis child’s valid Saskatchewan Health card(s) number
- \$500 issued per Métis child
- A maximum of \$2500 per Métis family
- An online application must be completed, with all supporting document information provided
- Funding will be available from April 6, 2020 to August 15, 2020 or until all funds have been dispersed

All applications will be reviewed and approved by an MN-S Committee.

****Please note: MN-S will review all applications however a completed application does not guarantee funding. Duplicate applications will be null and void.**

You do not need to wait to apply for funding. The ELCC committee and MN-S Registry will be working together to ensure applicants meet the registration requirements. Registered Métis citizens and those with an application in process, will be considered for funding. If applicants apply and the Métis child(ren) listed are not registered or in the process of getting registered, the MN-S Registry will contact the applying parent to review the registration process.

Funding will be in the form of a cheque and mailed to address provided.
